ASSESSMENT OF STUDENT MEETING COURSE OBJECTIVES:

A term paper (we or your supervisor will decide upon one) in which you actively participate and contribute. This will be a combination of peer and instructor assessment.

課程時間：

本課程預計連續開立三學期，為科技管理研究所博士班必修課程。

博一結束時，學生應已經確認其論文指導教授。博二上修「科技管理論文寫作實習（一）」，博二下修「科技管理論文寫作實習（二）」，博三上規劃為國外進修，博三下修「科技管理論文寫作實習（三）」。

教學目標：

本課程系列主要是配合科管所博士班畢業規定中要求：學生畢業前，應至少發表學術期刊論文一篇。

1. 科技管理論文寫作實習（一）：介紹科技管理領域之重要文獻與期刊標的，督促同學確認論文研究方向。
2. 科技管理論文寫作實習（二）：督促同學完成一篇有在期刊發表潛力的論文草稿一篇。
3. 科技管理論文寫作實習（三）：修習時，學生應至少已有一篇論文被 AOM 或其他的國際學術會議接受發表（論文若非於 AOM 年會發表，則需於所務會議提案討論通過，並需以該研究領域內相當於 AOM 等級之國際研討會為主）。本課程的目的在於，督促並協助同學至國外研討會發表論文，以及將論文投稿至學術期刊。
