課程簡介：

歷史考古學以考古學的理論與方法研究歷史時代的社會與文化，其本質是一門融合考古學、人類學、及歷史學的學科。在文字已經被發明出來的時代，歷史考古學的研究可以使用哪些材料幫助我們認識過去？考古證據與文字史料間的關係為何？有哪些議題特別受到關注？本課程將從這些基本提問出發，介紹歷史考古學在新舊大陸多元的發展，以及台灣及周邊地區近年的研究方向。

本課程將同時以講授與討論進行。除了課間的兩個作業之外，學生將獨立撰寫一篇與本課程相關之研究報告。請於第九週前繳交研究計畫，並於期中報告進度並互相同回饋，最後於期末報告成果。

3. 藉由作業與報告培養搜集材料與分析的能力
