Overview

Family is a key institution in the society and tends to be seen as a "timeless" existence. However, family forms, practices, and relations are diverse and changing across time and space. What we consider as the "normal" family today could be reviewed as abnormal at other times and spaces. As an important social institution, family processes intersect and overlap with other dynamics of social life, and shape what a society is and how people carry out their lives. This course explores key concepts and debates about changing family life, family institution, and intimate relations. Issues of social changes (modernity and development), privilege, inequality (gender, sexuality, class, ethnicity, nationality, age), and the transformation of family institution will be the core inquiries of the course.

Course Requirements and Expectations

1. Participation (20%)

Students are expected to attend class regularly and participate actively in discussion and in dialogue with one another. They must read carefully and critically the assigned reading before each class. At least 1-2 times during the semester, each student must volunteer to lead the discussion for the first half of the class.

2. Weekly Short Response Papers (30%)

Students are required to write short response papers (approximately one to two pages,每週 讀本超過四份者,可選讀三份) during the course of the semester.選擇期中及期末方案 A 的整學期要交 8 篇,選擇方案 B 的要交 6 篇。 Each paper should be a response to that week's set of readings (and films, if applicable). It should include a precise and concise summary of the main arguments in the readings, identify the common themes and/or points of disagreement among them, and pose an interesting question or series of questions about the material under investigation.

3. Midterm paper due by November 30, 25%

A. Short Syllabus

Students are required to design a **five-week, meeting twice a week** undergraduate course syllabus on a subject that combines the sociology of family (broadly defined) with each student's respective scholarly interest. The syllabus assignment should fulfill the following conditions: the course meets two days a week and two articles (Chinese and/or English) for each meeting; having a brief statement of each week's designed themes and summarizing each assigned article's main points/arguments. This exercise is intended to demonstrate students' abilities to identify and organize literature in creative ways that open up new avenues in the exploration of these subject matters. By October 5, students are required to turn in a brief outline of their proposed syllabus and its objectives.

- B. 個人家庭/家族史或與家庭相關主題的口述歷史、生命歷史,5個紀錄訪談稿與資料收集整理。擬定一個與家庭相關的主題,以自己、其他家族或與主題相關人物來設計研究對象,研究方法以口述歷史/生命史方式來收集相關文字、文件及影像資料,至少要有5名或以上的訪談、每個訪談至少累積1.5小時或以上的深入訪談。這個作業要完成訪談及完成1/2的非逐字但詳細的訪談騰稿。請在10月5日寄給我簡單的作業主題及工作計劃。
- 4. Final Paper due by January 8 2024, 25%
- A. Literature review or research proposal (10 pages)

Students are required to turn in a final paper (approximately 10 pages) which can be in the form of literature review or thesis proposal related to family studies. The topics can be related to the midterm short syllabus assignment.
